19 1. I, Joe Martino, declare that I have personal knowledge  
20 of the matters contained herein. If called as a witness, I can  
21 and will competently testify to the matters contained herein.

22 2. I have met Mr. Prantil on several occasions, and he had  
23 me serve subpoenas on Mr. Kraig Dorner's marital dissolution  
24 case.

25 3. On one occasion, I was in Mr. Prantil's outer office  
26 while Mr. Dorner and Mr. Prantil were in a meeting. I could hear

1 each of them talking very loudly to each other. At the end of  
2 the meeting, when they were in the outer office area, Mr. Prantil  
3 apologize to Mr. Dorner for yelling at him. He explained that he  
4 is so passion about Mr. Dorner's case and he loves Mr. Dorner  
5 like a brother.

6 4. On the morning of April 19, 2018, I was with Mr. Dorner  
7 when he parked his truck (with the banners displayed) near Mr.  
8 Prantil's office. Shortly after parking the truck, an attorney  
9 from the office came outside and taped plastic bags on the  
10 banners, and he asked me if the vehicle was owned by Mr. Dorner,  
11 and he commented that he thought it was very funny. Afterwards,  
12 Mr. Prantil came over to the truck and took photos of it, and he  
13 called over to Mr. Dorner and I standing on the other side of the  
14 street and said, "You fucked with the wrong person." During this  
15 entire incident, Mr. Dorner was across the street, and he did not  
16 say anything to Mr. Prantil or the other attorney. Mr. Dorner  
17 called the police and after they arrived, he walked across the  
18 street to talk to the police. Mr. Dorner told the officers that  
19 it was his vehicle and there was no further discussion. The two  
20 officers removed the plastic bags and went into Mr. Prantil's  
21 office. When they came out, they told us that the people inside  
22 said it was because Mr. Prantil has a case against Mr. Dorner,  
23 and Mr. Dorner is trying to force him to settle. Mr. Dorner  
24 explain to the officers that he is only trying to warn the public  
25 about Mr. Prantil. One officer informed Mr. Dorner that he is

2 vehicle there for up to 72 hrs.

3 5. I have accompanied Mr. Dorner, on numerous occasions,  
4 throughout San Diego, with the banners affixed to his vehicle,  
5 and there has never been any problems or conflicts.

6 6. I declare under penalty of perjury under the laws of  
7 the State of California that the foregoing is true and correct,

9 and, to those matter, I believe them to be true and correct.
