18 1. I, Richard Sprunger, declare that I have personal
19 knowledge of the matters contained herein. If called as a
20 witness, I can and will competently testify to the matters
21 contained herein.

22 2. I have known Mr. Kraig Dorner for approximately 30
23 years. We met while we were serving on SEAL Team 5. Our
24 friendship has continued after my retirement from the Navy and
25 during my 17 year career with the San Diego Fire Department. I

1 have never seen or heard of Mr. Dorner losing his temper, as Mr.
2 Prantil and his "private investigator", Mr. Flynn have claimed.

3 3. I have accompanied Mr. Dorner to Mr. Prantil's office
4 on several occasions, and during meeting Mr. Prantil showed me a
5 photograph of a woman and claim she was a client that was
6 "working off her bill." Mr. Dorner used that same photograph on
7 a sign that he put on his truck, but the photograph that Mr.
8 Dorner displays on his sign has the woman's face and genitals
9 blurred.

10 4. I also has accompanied Mr. Dorner to Mr. Prantil's
11 office when Mr. Dorner signed a Substitution of Attorney form,
12 relieving Mr. Prantil of his duties as Mr. Dorner's attorney,
13 which is also the same time that Mr. Dorner took possession of
14 his marital dissolution file. At that meeting, Mr. Prantil and
15 his "private investigator", Mr. Flynn are claiming that Mr.
16 Prantil served Mr. Dorner fee arbitration papers. That claim is
17 false. No papers were served by Mr. Prantil, and his "private
18 investigator", Mr. Flynn was not present.

19 5. I have read Mr. Prantil's declaration where he stated
20 that he is afraid of Mr. Dorner because Mr. Dorner owns firearms
21 and ammunition. Mr. Prantil also owns firearms. I assisted Mr.
22 Dorner in cleaning several of Mr. Prantil's firearms, and I
23 assisted Mr. Dorner in assembling an unassembled AR-15 Rifle,
24 owned by Mr. Prantil.

25 6. On May 14, 2018, I was with Mr. Dorner when he picked

1 up his truck that was parked in front of Mr. Prantil's office.
2 Mr. Flynn, who claims to be a private investigator was standing
3 by Mr. Dorner's truck talking on his cell phone. Due to Mr.
4 Flynn's presence, Mr. Dorner decided to wait, a block away, to
5 pick up his truck, to avoid a confrontation with Mr. Flynn. Once
6 Mr. Flynn walked away from Mr. Dorner's truck, Mr. Dorner walked
7 to it and drove it away.

8 7. I declare under penalty of perjury under the laws of
9 the State of California that the foregoing is true and correct,
10 except those matters that I have stated on information and belief
11 and, to those matter, I believe them to be true and correct.
